## **Reports of Officers and Standing Committees**

## Editor-in-Chief

POLENCHUK said The Gateway has hired an Arts & Culture Editor, Brooklyn Hollinger. She is posting deputy editorships and they will go through training when deputies are hired. Protests on campus have taken up much of staffs time and energy. She is working to set up times at which to meet with the new University of Alberta Students' Union (UASU executives), including the past and current presidents, Christian Fotang and Lisa Glock. She is working on The Gateway's budget and is meeting with an auditor to talk about doing a full audit. A \$1000 check that was lost in a robbery was reimbursed on May 6. She is meeting with Nigel from the UASU to speak about getting grants. TWITTEY is revamping the Volunteering Form. She has organized times to have weekly meetings with TWITTEY and HABIBZAI separately.

#### **Executive Director**

HABIBZAI started transitioning and training. He has transitioned the names on all relevant accounts. He met with previous executive director, Jonas Smith. He has learned to generate monthly report and payroll. He is working on collecting outstanding payments from groups/people that purchased ads and haven't paid for them yet. He has created a new ad package and sent this package out to previous clients and over 100 companies. To incentivize ad sales during the summer months, prices for ads have been lowered by 40 per cent. With POLENCHUK, he has started working on The Gateway's budget. He has emailed Marc Dumouchel to inquire about how much revenue The Gateway will receive from the recently reinstated fee.

## Managing Editor

TWITTEY summarized the details available in the Managing Editors May report. As May was an active month for news coverage, TWITTEY said it is likely May's numbers will be higher than Aprils. Numbers for the pitch email and Campus Roundup have not seen any major changes.

## **Finance Committee Report**

Due to frequent and recurrent issues with BMO, POLENCHUK said she and HABIBZAI are looking into switching away from BMO.

TEELING says hopefully the account will be set up in time for collecting student fees. BROOKS says he likes Quickbooks.

POLENCHUK says they may create a presentation on options for June.

BROOKS recommends ATB or a credit union.

BROOKS suggests opening up a new account with another bank before closing the BMO account.

BROOKS makes a motion for POLENCHUK and HABIBZAI to explore banking options and present options by May 31st. HENNIG seconded. The motion passed unanimously.

TEELING said three GSJS Board positions need to be filled. She asks members to inform others of the open positions.
